NEW BUSINESS:

- **Resolution approving the continuation of the employment of Police Chief Rick Jewell and the status of Mayor Noeman authority to unilaterally dismiss him.**

Mayor Noeman read a letter to the Board regarding the dismissal of Chief Jewell.

Alderman Harris made a motion to approve a Resolution of the continuation of the employment of Police Chief Rick Jewell, and the motion was 2nd by Alderman Mason:
vote passed 4-1 (Mayor Noeman voted no)

- **Resolution approving the extension of the furlough of the Mason Fire Department Staff, as imposed in the Special Call Board Meeting on October 30th, 2025.**

Alderman Rivers read the Resolution approving the extension of the furlough of the Mason Fire Department employees and staff members that was adopted on October 30, 2025, is hereby extended indefinitely, effective immediately upon adoption of this Resolution, and shall remain in effect without pay unless and until modified or terminated by subsequent action of the Board. Alderman Mason made a motion to accept the Resolution, and the motion was 2nd by Alderman Broadnax: vote passed 4-1

(Mayor Noeman said he was not recognizing the Resolution)

- **Town to purchase turkeys for the citizens**

Mayor Noeman announced that turkeys would not be distributed.
